Introduction

"Whois" is a query-based protocol used to look up certain information related to domain

names, including the name and contact information of a particular domain name registrant, the

domain name registrar and the name servers for the domain name, among other information.

This information is provided by the registrant of each domain name, and it is the registrant's

responsibility to ensure that its information is complete and accurate, including updating their

information if a change has occurred to the information provided.

Annco Inc. ("Ann") provides access to its Registration Data Directory Service (Whois) Database

("Whois Database") solely for informational purposes, to assist you in obtaining information

about the domain names registered in our TLD. Our Whois Database only contains information

related to domain names that are currently registered within the TLD operated by Ann.

Using Our Whois Database Query Services and Whois Data

By querying our Whois Database, you are agreeing to comply with these terms so please read

them carefully.

You shall not misuse the Whois Database. It is intended solely for query-based access.

You shall not use the Whois Database to allow, enable, or otherwise support the transmission

of mass unsolicited, commercial advertising or solicitations. You shall not access our Whois

Database through the use of high volume, automated electronic processes that send queries or

data to the systems of Ann or any ICANN-accredited registrar. You shall not use the Whois

Database to interrupt, disrupt, or interfere in the normal business operations of any registrant.

You shall only use the information contained in the Whois Database for lawful purposes.

We record certain details about queries to our Whois Database for the purposes of detecting

and preventing misuse. We reserve the right to restrict or deny your access to the database if

you fail to comply with these terms, or to ensure the operational stability of the Whois

Database. Standard Whois database searches, including ours, are strictly rate limited for

unidentified third parties, which helps to prevent data mining and other abuses of this system.
